INFORMATION PERTAINING TO MEETINGS OF PRESBYTERY Per Presbytery Manual Chapter V

<u>Number of Meetings</u> — Our *Book of Order* (G-3.0304) requires presbytery to hold stated meetings at least twice each year. At this time, there will be four <u>STATED</u> meetings for 2017: February 11, May 9, August 26, and November 14.

Kind of Meetings – Besides stated meetings there are adjourned meetings and special meetings.

<u>Adjourned Meetings</u> – Held to conclude unfinished business of preceding stated meeting. New Business may be placed on docket.

<u>Special Meetings</u> – The moderator shall call a special meeting at the request of, or with the concurrence of, two ministers and two elders being of different churches. Should the moderator be unable to act, the stated clerk shall, under the same conditions, issue the call. If both moderator and stated clerk are unable to act, any three ministers and three elders, the elders being of different churches, may call a special meeting. The Synod may direct the Presbytery to convene a special meeting for the transaction of designated business. Notice of a special meeting shall be sent not less than ten (10) days in advance to each minister and to the session of every church. The notice shall set out the purpose of the meeting and no other business than that listed in the notice shall be transacted.

<u>Who Determines Type of Meetings?</u> – The presbytery itself. If the business at a stated meeting is not completed in the time allowed on the docket, then the presbytery votes to extend the time on that day or votes to schedule an <u>adjourned</u> meeting later. <u>Special</u> meetings may be called in conformity with presbytery's policy, expressed in its manual.

<u>Docket Preparation</u> – The Presbytery Meeting Planning Committee composes the docket. Time periods for committee reports are arranged in consultation with chairs and others responsible for reports.

<u>Docket Problems</u> – The times listed for the presentation of reports are only general orders, and not orders of the day, unless specifically noted (see Procedural Rule A). Frequently, debate bogs down over procedural matters, and controversial issues create considerable discussion. Presbytery can always limit debate. Candidates and transferring ministers of necessity may require special considerations for their examinations because of such things as travel schedules and seminary schedules. The docket may be amended at any time during the meeting. Commissioners should be aware of possible extension of time needed for such amendments and the possible delay in adjournment.

PROCEDURAL RULES

5.5. OPERATING PROCEDURES

- 5.5.1. The Presbytery shall in its proceedings abide by the requirements of the Constitution of the Presbyterian Church (U.S.A.), its Standing Rules or Manual of Operations, and Robert's Rules of Order (newly revised) in this order. A list of procedural rules adopted by Presbytery shall be printed on the inside cover of each handbook.
- 5.5.2. A report of any agency of Presbytery requiring more than 10 minutes of Presbytery time may be made an Order of the Day.
- 5.5.3. Reports having been mailed out in advance, the committee chairperson will shall not read the report except to make reference to a few highlights of the report and to recommendations by numbers, moving their adoption.
 - A. Any reports not included in the Handbook shall be submitted as part of a Supplemental Report available either electronically or on paper distributed prior to the beginning of the Presbytery meeting at which the report is presented.
 - B. Any report not so circulated shall not be received by the Presbytery except by approval of the governing body by a two-thirds vote of those present and voting. If a group wishes to submit such a report, a person shall summarize its content and purpose before the vote is taken.
- 5.5.4. On matters where there may be deep concern, possible controversy or lack of information, the committee making the report shall provide critical background information, so that the governing body may expeditiously make wise and considered decisions.
- 5.5.5. Debate shall be free and open, with equal time being given to proponents and opponents insofar as possible.
- 5.5.6. Any member of the governing body desiring to speak must stand, identify themselves by name and congregation, be recognized by the Moderator, and go to a microphone if available.
- 5.5.7. A member of the presbytery may speak twice on any particular motion, and not for more than a total of five minutes, but the second time may only be granted after all who have not yet spoken have had an opportunity to do so. The maker of the motion is entitled to speak first, if desired
- 5.5.8. Lengthy motions must be written out and presented to the Stated Clerk.
- 5.5.9. References to the following procedures from Robert's Rules of Order may prove useful:
 - A. A committee recommendation does not require a second to be on the floor.
 - B. Other motions require a second prior to discussion or action.
 - C. When there is no apparent disagreement or objection to a motion, the Moderator may declare it is adopted by common or general consent.
- 5.5.10. No flash photography will be allowed during the worship service at meetings of Presbytery.
- 5.5.11. When Presbytery meets in a location where seating is limited, priority shall be given to voting members for seating within the meeting area. If it is necessary to use other rooms for overflow seating, visitors and other non-voting members shall use these areas.

5.5.12. **QUORUM**:

A quorum of the Presbytery shall be any ten teaching elders and ten ruling elders from at least ten different congregations. (G-3.0304).

Include our disagreements in our prayers, not praying for the triumph of our viewpoints, but seeking God's grace to listen attentively, to speak clearly, and to remain open to the vision God holds for us all.

FINAL REPORT OF THE ADMINISTRATIVE COMMISSION BUCKTON PRESBYTERIAN CHURCH

The Listening Response Team for Buckton Church was appointed an Administrative Commission on May 10, 2016. The AC members are: TEs Lisa Wilson (chair), Maren Sonstegard-Spray; REs Donna Lanaghan, Eric Hulett, Adrian Burt. (Maren Sonstegard-Spray stepped down in June due to Sabbatical. TE Joan Wilson was appointed to serve.)

The AC met with the session and Commissioned Ruling Elder James Boyette on June 7 to apprise them of presbytery's decision to appoint the former LRT as an AC and to negotiate next steps in the AC process. At this meeting, all session members present and CRE Boyette renounced jurisdiction. One session member not present later renounced jurisdiction, as well. The AC became the session, having been granted original jurisdiction by the Committee on Relational Ministry on May 19.

Listed below are presenting issues that needed to be resolved, and since have been.

- Deeds of Trust for church and property (including manse) have been located and placed in the bank safe deposit box.
- July 1: Jean Steidel began serving as CRE, having been commissioned by Committee on Relational Ministry.
- July 3 congregational meeting: session size was reduced from 12 to 6, thus more in line with the congregation's size; quorum for congregational meeting was set at eight members.
- A "Celebration of New Life" worship service was held on August 7. Many thanks to the presbytery for enthusiastic support and attendance.
- A Nominating Committee was elected by the congregation on July 3. On August 21, the following nominees were elected to serve: Class of 2017 Ed Clark, Gary Eaton; Class of 2018 Josh Logan, Lisa Schlosser; Class of 2019 Doug Dicks, Scott Schlosser. The elders elect attended two subsequent session meetings and were trained using the PCUSA material *Being Reformed: Faith Seeking Understanding, Workbooks One and Two*. The elders elect also attended the presbytery's Big Event in September, all taking classes with Dr. Roy Martin on Presbyterian Polity. Training continues to take place during each session meeting. The elders elect were examined on November 20 and installed during worship on December 11.
- RE Doug Dicks was elected clerk of session, commencing January 2017; Debby Seekford and RE Josh Logan were elected co-treasurers, commencing January 2017.
- The 2017 operating budget was prepared and approved by the session. For the first time in many
 years, the session has included the Presbytery of Shenandoah's Shared Mission Support in its
 budget.
- Financial discrepancies with the Board of Pensions in regard to James Boyette were finally settled in December, 2016.
- The new session has agreed with the AC that a Holy Cow *Conversation* will be a good "next step" for the congregation as it considers opportunities for mission and ministry in the coming years.

The Administrative Commission extends appreciation to the presbytery for its trust as we have attempted to serve Buckton Church with integrity and peace. Special thanks to Roy Martin, Kerry Foster, Kim Stroupe, and John Peterson for their assistance. Our belief is that Buckton Church is in excellent hands with CRE Jean Steidel, and we give thanks to God for her ministry with that congregation.

Our work being accomplished, we respectfully request dismissal from service. The Buckton AC

FINAL REPORT OF THE ADMINISTRATIVE COMMISSION BUFFALO GAP PRESBYTERIAN CHURCH

Members of the Commission: John McDonald – Interim Teaching Elder, Buena Vista Presbyterian Church, Jonathan Ytterock, Teaching Elder, Mt. Horeb Presbyterian Church, Judy Hensley, Certified Ruling Elder, Union Presbyterian Church, and Joyce Tipton, Ruling Elder, First Presbyterian Church Waynesboro.

Recommendation

The Administrative Commission for the Buffalo Gap Presbyterian church after meeting with the Session of the church for the past 10 months recommends that they not be dismissed to the Evangelical Covenant Order of Presbyterians and reports that the church wishes to remain within Shenandoah Presbytery.

Brief History of the process

As an LRT, we met several times during the months of March – May with the Session to get to know the Session and hear their concerns. They had issue with several decisions made by the PCUSA, but other issues were identified that mainly revolved around their not feeling fully supported by the Presbytery.

During this time the LRT held a meeting of the congregation to hear any other concerns that other members of the church wanted to voice. Several people were concerned about whether or not ECO would be able to fully support the church and keep it together. The LRT said we would follow up with our Stated Clerk and try to ascertain what kind of pastoral support ECO would be able to provide the church. We then tried to make contact with the remaining members of the congregation whom we had not met. We tried to make contact either by phone or in person and were able to contact all but one member.

A straw poll of the congregation was taken in June. The question put to the congregation members was, "Should the Buffalo Gap Presbyterian Church leave the PCUSA and unite with ECO." The congregation voted 5 to leave 2 to stay and 1 abstention. Both the Session and the LRT still questioned whether ECO was ready to take such a small church into their denomination and we questioned what kind of pastoral leadership they were prepared to give Buffalo Gap church. The church met with representatives from the Spring Hill church to hear what their experience with ECO had been. Meanwhile the LRT with the help of Stated clerk, Kerry Foster tried to find out from the ECO leadership what kind of pastoral care would be offered to the church. The LRT was never satisfied with the answers they received and felt that ECO would not provide the badly needed pastoral leadership for the Buffalo Gap church.

The LRT met with and received advice from the Committee on Relational Ministries voicing their reservations. They also continued to meet with the Session of Buffalo Gap and sensed that the congregation was not fully satisfied with the answers they had received from the meeting with ECO. Another Straw poll of the congregation was taken and this time the vote was 6 to leave and 6 to stay.

After this vote the CRM recommended to the Coordinating and Planning Commission that the LRT be named as an Administrative Commission with original jurisdiction. The CPC acted on that recommendation at the end of September. The now Administrative Commission met in late October with the Session to explain the Presbytery's action and discuss a resolution to the matter. The AC stated to the Session that we did not feel comfortable recommending the dismissal of the church due to the fact that half the congregation wanted to stay within the PCUSA, and that ECO did not seem prepared to deal with a congregation the size of Buffalo Gap. We felt that Shenandoah Presbytery could offer more pastoral support which we perceived as the biggest concern of the majority of the congregation.

The clerk of the Session and one other Session member could not in good conscience agree with this decision and resigned from the Session and subsequently moved their membership to the Spring Hill Church. The Session thanked them for their service and regretfully accepted their resignation. The other members of the church agreed with the AC opinion.

With the help of Committee on Pastoral Transitions the Session and the AC explored the possibility of sharing pastoral leadership with the Craigsville church. Gwen Carr who has been serving the Craigsville church as student pastor for some time entered into discussion with the AC and the Session about the possibility of serving as the pastor of Buffalo Gap as well as Craigsville. Gwen will soon be ordained as a member-at-large of the presbytery and after negotiations with both churches it has been agreed in principle that she wil, with the permission of Presbytery and the finalization of negations, serve both churches on a part time basis not to exceed 25 hours.

We the AC want to thank the good people and Session of the Buffalo Gap for their prayers and for their full cooperation during this time of discernment. The AC therefore recommends the Presbytery dismiss us and celebrate with Craigsville, Buffalo Gap and Gwen as they begin a new chapter in their ministries.

Mainline protestant denominations are seeing an increase of couples who are called to ministry and marriage together. Whether they served the same church, or are in different ministry settings, clergy couples (and other couples who are both engaged in professional ministry) face unique challenges. Research data on clergy couples is sparse, but ss of 2012, 12% of PC(USA) clergy surveyed by the Presbyterian Panel indicated they were part of a clergy couple. While more recent data has not been gathered it is likely that number has only increased. While the number of clergy couples is growing, very few resources to support them exist. Called Together: A Retreat for Married Couples in Professional Ministry will concentrate on the "Three R's" of this unique group. Relationships, Resources, and Renewal. (See item "d." for goals for each.)

b. Identify the name(s) of the committee, agency, or presbytery network that will have oversight of this initiative. 15

Massanetta Springs, a camp and conference center in covenant relationship with the Synod of the Mid-Atlantic is bringing together the support of the sponsoring presbyteries to launch "Called Together." The Planning Team, led by the Executive Director (who is half of a clergy couple with Rev. Kate Rascoe), is soliciting input from clergy couples from around the Synod to provide a meaningful opportunity for all participants. The sponsoring presbyteries have agreed to promote the event to the ministry couples within their presbyteries. While a few presbyteries are official sponsors, we will promote this opportunity throughout the Synod of the Mid-Atlantic.

c. Explain how this initiative necessitates the combined resources and energy of two or more Presbyteries and the Synod (or a Caucus and the Synod) and how this initiative will "enable a more efficient and effective accomplishment of the need."

While clergy couples are a growing population in our Synod and beyond, we are a small enough body that bringing together the efforts of multiple presbyteries will make Called Together more successful by allowing a larger community of ministry couples to participate.

d. List and describe the goals, objectives, and expected outcome of the mission or program being proposed.

Relationships – Intentional time to strengthen the relationship of the couple/family; as well as time to build relationships with other ministry couples who understand the unique challenges/successes of being called together. Resources – The planning team is recruiting leadership to equip participants for ministry when they return to their ministry settings. Participants will specifically work on a project that will help them after they leave the Called Together retreat. Renewal – Our chaplain couple will lead worship opportunities and spiritual exercises for participants to renew their spirits while attending the retreat, and to be equipped for ongoing renewal afterward.

- e. Provide the expected completion date.
 The Called Together Retreat will take place August 7-10, 2017.

THE STRONG MINISTERS PROGRAM

Mission Statement: The mission of the Strong Ministers Program is to foster strong and enduring Ministries by supporting the Teaching Elders, Stated Supply Pastors, and Certified Christian Educators of Shenandoah Presbytery.

The Strong Ministers Program has limited funds available to assist Teaching Elders, Stated Supply Pastors, and Certified Christian Educators serving in Shenandoah Presbytery. You are encouraged to make application immediately for the next disbursement in Spring 2017. Please read the guidelines carefully and be prepared to participate in this program in a collegial spirit! Guidelines

BACKGROUND: In 1948, the former Lexington Presbytery created a "Minister's Revolving Loan Fund" for the purpose of providing low interest loans for Ministers purchasing homes (many for the first time) upon retirement. Over time, this fund has grown and gone through many changes. Most recently, it has been known as the "Minister's Grant Fund", and it has continued to provide assistance.

Where applicable, Teaching Elders, full-time Certified Christian Educators, and Stated Supplies who qualify and are residing in West Virginia are asked to please apply first to the West Virginia Fund for Ministers before applying for a grant from the Strong Ministers Program.

Please be aware that it may not be possible to meet all requests. This is a shared, limited resource. The Strong Ministers Program Committee welcomes your suggestions for improving the allocation of this resource.

Since resources contributed for, and distributed by the Strong Ministers Program are designated funds held by the Shenandoah Presbytery Corporation for the benefits of the program, it is the Strong Ministers Program's understanding that awarded grants are distributed for restricted purposes. Should the purpose for which a grant is offered (e.g.in support of a ministerial sabbatical, continuing education, housing grant etc) cease to exist it is expected that the grant funds will be returned to the Strong Ministers Program account of Shenandoah Presbytery.

Who may apply? Installed Teaching Elders of Shenandoah Presbytery and Full-Time Certified Christian Educators, and Stated Supply Ministers who have served the same congregation(s) of Shenandoah Presbytery for 5 years or more, may apply for grant in any category. Retired Teaching Elders of Shenandoah Presbytery, who have served in Shenandoah Presbytery, may apply for assistance under the "Housing and Emergency Medical Expenses" portion of the Program.

ASSISTANCE IS AVAILABLE IN THREE BROAD CATEGORIES I. Housing Assistance A Grant of \$5,000 (Maximum) is a one-time grant. It is available to Teaching Elders, installed full-time or retired, and Full-Time Certified Christian Educators in good standing, and Stated Supply Pastors who have been under contract with the same congregation(s) within Shenandoah Presbytery for 5 years or more. If retired, the Teaching Elder must have served Shenandoah Presbytery in an installed capacity. This Grant is available at the time of a home purchase or mortgage refinancing within the bounds of Shenandoah Presbytery or upon the occasion of a move to a retirement facility within Shenandoah Presbytery. In the event that the number of requests exceeds the amount available in a given year, priority for distribution will be based on years of service within Shenandoah Presbytery will be used. Those who do not receive disbursements may make a similar request in subsequent application periods.

- II. <u>General Grants</u> General Grants are available for members of Shenandoah Presbytery defined in the "Who May Apply" Section above. Ordinarily, one grant per category, will be awarded per fiscal year. Priority will be given to those who have drawn less frequently from the Program."
- Emergency Medical Expenses: Medical expenses not covered by the Board of Pensions. Up to \$3,000/year maximum 22

- Seminary or College Debt : Up to \$1,000/year maximum. Application may be made once each year until the debt is retired.
- Continuing Education Grants for Ministers: Up to \$3,000/year maximum each year. This grant is available after three full years of installed service or 5 years of stated supply contracted service in the same call within Shenandoah Presbytery.
- Sabbatical Support: Up to \$6000.00/sabbatical. This grant is available after each six (or more) years of active service in Shenandoah Presbytery.

An applicant must provide a detailed explanation of the intended use of this request, including an itemized estimate of all costs involved in the projected sabbatical. The applicant's Session or appropriate body must give their endorsement of this request. If the applicant is a Teaching Elder of a Parish, that Parish Council shall give it's endorsement of the Sabbatical Plans. If the applicant is a member of Presbytery Staff, the plan shall be submitted to the Committee on Presbytery Administration, and then recommended to the Coordinating and Planning Commission. This Grant is payable to the employing church or organization within Shenandoah Presbytery.

• College Grant Fund: Up to \$1,000/year per child or spouse. This is for children and/or spouse of those defined in the "Who May Apply" section. This is an annual grant for undergraduate degrees. This is not a need based grant. In the event of a large number of applications, grants will be awarded equally, not to exceed the annual tuition fees of the applicant.

III. General Presbyter's Discretionary Fund for Ministers

The Strong Ministers Program will make provision for confidential assistance for purposes other than those already enumerated and for other emergencies through the General Presbyter's

Discretionary Fund for Ministers. This portion of the Strong Ministers Fund will be funded from the investment proceeds from the sale of the "Sunrise Avenue" house in Harrisonburg. This fund will be allocated at the sole discretion of the General Presbyter.

Should you have a concern that needs to be considered confidentially, please contact the General Presbyter, for this assistance.

OTHER INFORMATION

- * Those Minister members who are part of a clergy-couple shall be treated as two separate and independent individuals.
- * The Strong Ministers Program Review Committee will oversee the semi-annual distribution of Grants from the Strong Ministers Program. This committee will consist of seven members, of which five are to be Teaching Elders of Shenandoah Presbytery (three active and two retired) and two lay members. Further, at least one of the Minister members shall be a female Minister member of the Presbytery. This Committee will be created and maintained through the normal nominations process.
- * This Program will be reviewed and modified as necessary, and the Committee will adopt criteria by which disbursements may be made. For reasons of confidentiality, final approval and determination of all disbursements and decisions regarding the Program will rest with the Committee, which shall be accountable to Presbytery Leadership Team and the Presbytery of Shenandoah, through the Funds Administration Committee.
- * Please note that some Grants require the completion of a specified number of "years of service" to Shenandoah Presbytery.

Proposed Policy for Retirement Recognitions at Presbytery Meetings February 11, 2017

Basis:

The Committee on Relational Ministry (CRM) has a pastoral responsibility for its member ministers, especially in times of transition. At retirement, presbytery traditionally provides a brief time of recognition and celebration on its docket of business. The proposed policy strives to strike a balance between the celebration of each minister's ministry and stewardship of time on the docket.

Proposed Policy:

CRM will coordinate the elements of the service into its report to the Presbytery. Honorably retiring Teaching Elders will have the privilege of inviting a colleague or friend to speak briefly to their service to the church. The speaker shall be approved prior to the meeting and is to be limited to 5 minutes.

Note: We would ordinarily expect that a church or institution from which one is retiring would host another occasion when more lengthy toasts and remembrances would be appropriate where friends and members of Presbytery might be invited.

Note: Some members decline the speaker or cannot be present. In these cases the Presbytery will still act on the recommendation for honorable retirement.

COMMITTEE ON MISSION AND OUTREACH (CMO)

RECOMMENDATION:

That Presbytery approve the following Manual revisions:

4.2.3. Committee on Mission and Outreach (CMO)

Purpose: To coordinate local, national, and international mission work through congregations and mission communities by providing information and resources and to oversee and coordinate presbytery wide mission work. Coordinate and oversee local, national, and international mission work through congregations and mission communities. CMO will provide information, resources, encouragement and support.

4.2.3.1. Membership:

Chair, Vice Chair, Ten Members at Large Chair, vice-chair and ten members-at-large to include representatives of all mission communities if possible. Includes persons interested in encouraging and supporting local and international mission activity among the presbytery's congregations and mission communities.

4.2.3.2. <u>Responsibilities</u>:

- A. Receive and discuss reports regularly from all mission communities.
- B. Communicate with congregations and mission communities regarding mission opportunities.
- C. Oversee and staff and receive reports regularly from any presbytery wide mission endeavors.
- D. Conduct mission oriented workshops and mission fairs regularly.
- E. Inform congregations and mission communities of denominational mission opportunities.
- F. Provide mission resource materials for congregations and mission communities.
- G. Oversee and administer mission related funds of the presbytery.
- H. Keep an accurate list of all mission activities involving congregations and mission communities.
- Encourage and facilitate the creation of new mission communities around common missional interests.
- J. Promote ecumenical partnerships in mission.
- A. Assist congregations and mission communities to develop local mission, sharing ways to tell and show the Good News of Jesus Christ in host communities.
- B. Encourage focused short-term mission programs at national and international locations, such as the Summerlee and Baja mission trips.
- C. Foster long-term partnerships such as the Ethiopia partnership and Living Waters for the World.
- D. Develop and maintain support for denominational mission co-workers, and ecumenical and advocacy relationships.
- E. Encourage and facilitate the creation of new mission communities around common missional interests.
- F. Maintain an accurate list of all mission activities involving congregations and mission communities.

4.2.3.3. <u>Accountability</u>

Facilitate a process for churches and mission communities to evaluate and report on their mission activities, realizing that both congregations and CMO are accountable to the presbytery.

- A. Oversee and administer the mission-related funds of the presbytery.
- B. Receive and share reports from any local and presbytery-wide mission endeavors.

- C. Set criteria for the use of designated funds such as the Ramsey Fund and the Bernice Hiett Global Mission Fund ("Foreign Mission"), to support short-term international mission trips and activities by congregations, the Ethiopia Partnership, and Shenandoah Presbytery.
- D. Serve as the conscience of the presbytery by encouraging advocacy efforts on behalf of poverty alleviation, justice and compassion.

4.2.3.4. Communications

Inform, educate and communicate with congregations and mission communities regarding mission opportunities.

- A. Use presbytery forums, workshops, the website, and electronic messages to disseminate information and to educate members about successful mission work.
- B. Identify and promote opportunities for short-term mission in the presbytery and beyond.
- C. Inform and advise congregations and mission communities of denominational mission opportunities.
- D. Conduct mission-oriented workshops and mission fairs regularly to provide training in best practices.
- E. Use mission reports as a way to encourage congregations to engage in similar work in their own context.

4.2.3.5. Support

Provide support for congregations and mission communities who participate in, develop and implement local, national and international mission.

- A. Call for congregations to pray for and encourage each other in their mission work.
- B. Serve as a resource for guest speakers about good mission practice* with local congregations and for presbytery events.
- C. Provide mission resource materials for congregations and mission communities.
- D. Identify models of good mission practice* within the presbytery and connect others who are interested in similar missions.
- E. Maintain a list of and encourage congregations to pray for presbytery-sponsored Young Adult Volunteers and for all mission co-workers.

When the chair of a committee is unable to attend a meeting, the vice-chair shall attend in their place bringing reports, actions, and requests from that committee. The vice-chair will have voice and vote in the meeting of CPC. Further, should the chair of a committee be unable to attend a presbytery meeting, the vice-chair is charged to attend and bring the work of the committee in its fullness to the floor of presbytery, with both voice and vote.

COMMITTEE ON EDUCATIONAL RESOURCES (CER)

Recommendation:

As a result of the Committee on Educational Resources' charge to determine the Presbytery's interest in several specific ministries and working from responses to a "Priority Survey" of congregational interests, the CER recommends:

• Continued support of SPYCE (Shenandoah Presbytery Youth Council Extraordinaire) and UKirk (collegiate ministries) and reach out to all youth ministry groups and colleges in the Shenandoah Presbytery who need funding and program support.

Oversight: Committee for Educational Resources – annual evaluation with committee members as liaisons working with SPYCE and Ukirk leaders.

<u>Funding</u>: primary source would be earnings from the Blue Memorial Fund, restricted funds designated for "youth work" approved by the Committee for Educational Resources (funds held by Shenandoah Presbytery Corporation).

• Continue offering church camping, conference, and college scholarships to Shenandoah Presbytery eligible youth.
