# INFORMATION PERTAINING TO MEETINGS OF PRESBYTERY Per Presbytery Manual Chapter V

<u>Number of Meetings</u> – Our Book of Order (G-3.0304) requires presbytery to hold stated meetings at least twice each year. At this time, there will be four <u>STATED</u> meetings for 2023:

- Tuesday, February 28 Zoom
- Saturday, May 20, Staunton Third Church
- Tuesday, August 22 Zoom
- Saturday, November 4, Opequon Church

<u>Kind of Meetings</u> – Besides stated meetings there are adjourned meetings and special meetings.

<u>Adjourned Meetings</u> – Held to conclude unfinished business of preceding stated meeting. New Business may be placed on docket.

<u>Special Meetings</u> – The moderator shall call a special meeting at the request of, or with the concurrence of, two ministers and two elders being of different churches. Should the moderator be unable to act, the stated clerk shall, under the same conditions, issue the call. If both moderator and stated clerk are unable to act, any three ministers and three elders, the elders being of different churches, may call a special meeting. The Synod may direct the Presbytery to convene a special meeting for the transaction of designated business. Notice of a special meeting shall be sent not less than fifteen (15) days in advance to each minister and to the session of every church. The notice shall set out the purpose of the meeting and no other business than that listed in the notice shall be transacted.

<u>Who Determines Type of Meetings?</u> – The presbytery itself. If the business at a stated meeting is not completed in the time allowed on the docket, then the presbytery votes to extend the time on that day or votes to schedule an <u>adjourned</u> meeting later. <u>Special</u> meetings may be called in conformity with presbytery's policy, expressed in its manual.

<u>Docket Preparation</u> – The Presbytery Meeting Planning Committee composes the docket. Time periods for committee reports are arranged in consultation with chairs and others responsible for reports.

<u>Docket Problems</u> – The times listed for the presentation of reports are only general orders, and not orders of the day, unless specifically noted (see Procedural Rule A). Frequently, debate bogs down over procedural matters, and controversial issues create considerable discussion. Presbytery can always limit debate. Candidates and transferring ministers of necessity may require special considerations for their examinations because of such things as travel schedules and seminary schedules. The docket may be amended at any time during the meeting. Commissioners should be aware of possible extension of time needed for such amendments and the possible delay in adjournment.

#### PROCEDURAL RULES

#### 5.5. OPERATING PROCEDURES

- 5.5.1. The Presbytery shall in its proceedings abide by the requirements of the Constitution of the Presbyterian Church (U.S.A.), its Standing Rules or Manual of Operations, and Robert's Rules of Order (newly revised) in this order. A list of procedural rules adopted by Presbytery shall be printed on the inside cover of each handbook.
- 5.5.2. A report of any agency of Presbytery requiring more than 10 minutes of Presbytery time may be made an Order of the Day.
- 5.5.3. Reports having been mailed out in advance, the committee chairperson shall not read the report except to make reference to a few highlights of the report and to recommendations by numbers, moving their adoption.
  - A. Any reports not included in the Handbook shall be submitted as part of a Supplemental Report available either electronically or on paper distributed prior to the beginning of the Presbytery meeting at which the report is presented.
  - B. Any report not so circulated shall not be received by the Presbytery except by approval of the governing body by a two-thirds vote of those present and voting. If a group wishes to submit such a report, a person shall summarize its content and purpose before the vote is taken.
- 5.5.4. On matters where there may be deep concern, possible controversy or lack of information, the committee making the report shall provide critical background information, so that the governing body may expeditiously make wise and considered decisions.
- 5.5.5. Debate shall be free and open, with equal time being given to proponents and opponents insofar as possible.
- 5.5.6. Any member of the governing body desiring to speak must stand, identify themselves by name and congregation, be recognized by the Moderator, and go to a microphone if available.
- 5.5.7. A member of the presbytery may speak twice on any particular motion, and not for more than a total of five minutes, but the second time may only be granted after all who have not yet spoken have had an opportunity to do so. The maker of the motion is entitled to speak first, if desired.
- 5.5.8. Lengthy motions must be written out and presented to the Stated Clerk.
- 5.5.9. References to the following procedures from Robert's Rules of Order may prove useful:
  - A. A committee recommendation does not require a second to be on the floor.
  - B. Other motions require a second prior to discussion or action.
  - C. When there is no apparent disagreement or objection to a motion, the Moderator may declare it is adopted by common or general consent.
- 5.5.10. No flash photography will be allowed during the worship service at meetings of Presbytery.
- 5.5.11. When Presbytery meets in a location where seating is limited, priority shall be given to voting members for seating within the meeting area. If it is necessary to use other rooms for overflow seating, visitors and other non-voting members shall use these areas.

# 5.5.12. **QUORUM**:

A quorum of the Presbytery shall be any ten teaching elders and ten ruling elders from at least ten different congregations. (G-3.0304).

- Commissioned Ruling Elders providing particular pastoral services, as authorized by presbytery
- Certified Christian Educators who are serving in an educational ministry under the jurisdiction of the presbytery

Such service does not count towards the number of ruling elders a congregation is entitled to send.

# STATED CLERK REPORT

# I. FOR INFORMATION:

The Administrative Commission to Bethel Church reports that the legal matters with the Church are almost complete for their move to ECO.

## COMMITTTEE ON CHURCH VITALITY AND TRANSFORMATION (CCVT)

MEMBERS: Jaci Smith Patman (Chair); Casey Clark, Rick Comstock, Jo Ann Harman, Mary Jo Johnson, Tracie Martin, Punker Robertson, Alexa Smith; Nancy Meehan Yao, Associate General Presbyter, Staff Support.

PURPOSE: To provide processes and support for congregations that have an identified need, willingness, and ability to engage in spiritual and/or programmatic growth which can lead to deeper commitment both within and beyond current membership.

MEETINGS: First Monday of the Month, 1:00 pm via Zoom.

As of this writing, the CCVT has met once since the last Presbytery Meeting, on September11, delayed due to the Labor Day holiday. Our next meeting is scheduled for November 6.

At our September 11 meeting, the Committee voted to fund the following grant requests:

- New Monmouth PC \$750 Ministry Program Grant to fund special event costs, including speaker fees (for Karen Swallow Prior), for a one-day gathering to consider how cultures inform our approaches to worship. Pastor Casey recused himself for the vote.
- Hebron PC \$1000 Innovations in Worship Grant to cover costs related to accessing reliable internet and wifi for streaming; and \$900 Ministry Program Grant to empower Hebron to reinvigorate their "parking lot ministry" for members who want to come to church Sundays but listen in to worship from their cars out of a concern for safeguarding their health.

AGP Nancy Meehan Yao informed the Committee that a PneuMatrix follow-up meeting will be planned early in 2024.

#### COMMITTEE ON PRESBYTERY ADMINISTRATION (CPA)

"The purpose of the C.P.A. is to oversee the management of presbytery funds, property, and staff" (from *The Presbytery Manual*).

Members of the C.P.A.: Hannah Bush, Betsy Glendye, Eric Hulett, Fletcher Hutcheson, Jim Johns, Jim Lunde, Clayton Rascoe, Harold Tongen, Dick Travis, and Tom Van Meter

The C.P.A. held an in-person meeting on May 18, 2023 at Massanetta Springs. Hannah Bush serves as our secretary.

Heather Carter presented a preliminary 2024 presbytery budget. Membership for 2022 in the presbytery's congregations decreased by 511 members. The income from per capita in 2024 will reflect that. The Committee on Mission and Outreach has requested that \$2,000 be added to their budget to support two missionaries, Cindy Correll and Doug Dicks, who are from our presbytery. The amounts for office cleaning and insurance are reduced. Equipment rental, technology, and website/domain expenses have increased. The budget lines for internet and telephone now are separated because those services are provided by different companies. The C.P.A. requested Heather to present the figures for possible 3%, 5%, and 7% cost of living adjustments (C.O.L.A.) for the presbytery staff members at the September meeting for our discussion.

Heather also gave us an update on 2023 per capita pledge payments from the congregations. Additionally, she reported that the actual expense for changing the presbytery's internet server was \$9,080.05. The amount that had been allocated for changing servers was \$20,000. The C.P.A. approved Heather's request that from the allocated amount, \$1,760 be used to cover server expenses for the remainder of 2023. The C.P.A. also approved that the remaining unused portion of \$9,396.25 (which includes some interest earned) from the original amount allocated be returned to the investment fund from which it came.

The C.P.A. had a "Zoom" meeting on Thursday, September 21st. Clayton Rascoe presented a proposed policy for handling the assets of dissolved congregations. He agreed to obtain further input on the proposed policy and to bring up the policy at a future C.P.A. meeting. Clayton also reported that Open Doors, an organization working with homeless persons in Harrisonburg, will know before the end of 2023 if it will be rewarded the contract by the City of Harrisonburg to operate at the former North Main Street presbytery office property.

The C.P.A. discussed the different C.O.L.A. increase options for the 2024 presbytery budget that we had requested from Heather Carter. The C.P.A. approved recommending to the presbytery a 2024 budget with a 3% C.O.L.A. increase for the presbytery staff members. With this recommended budget, the 2024 per capita asking amount would be \$54.92. The per capita asking in 2023 was \$52.00.

The C.P.A. approved a request from the Committee on Relational Ministry for a grant totaling \$5,925 to support the participation of Tommy Carrico, Amanda Thomas, and Julia Burkley in the Community of Ministry and Worship program. The grant will be drawn from the 2018 Fund. The next scheduled meeting of the C.P.A. will be at 1:30 p.m., Thursday, October 19<sup>th</sup>, via "Zoom".

Kate Lewis Brown, who is co-leader with Dwight could not be there as she was with her husband, John who was having surgery that day. The Community Cup and More is presently a LLC owned by Rachel Crumley, Kate and John Brown. Dwight manages the ministry side and Kate the Coffee Shop side as they work together for the good of both sides of this ministry.
- Discussion was had regarding non-profit status and how to achieve this. The committee voted to create a c3 called NWC in WV and populate the board of directors to provide leadership for the New Worshiping Communities in WV. The representatives of Community Cup and More agreed that they would become an incorporated entity owned the nonprofit NWC in WV c3.

# SHENANDOAH PRESBYTERY CORPORATION FINANCIAL REPORT TO THE MEMBERS OF THE CORPORAITON July 1, 2022 THROUGH JUNE 30, 2023

The Corporation's fiscal year is from July 1<sup>st</sup> to June 30<sup>th</sup>. Net investment income will be available for use/distribution at the end of the current calendar year pursuant to directions on file. Funds are available for withdrawal quarterly and must be requested in writing prior to the end of the quarter. Quarterly payment is necessitated because the Corporation selects long term investments that are not intended to be available on a demand basis. All accounts due to churches and trusts are invested in the same manner as a mutual fund. A valuation of the investment securities held is made at the end of each quarter to determine the amount allocable to each account held by the Corporation.

Total assets of the Corporation on June 30, 2023 totaled \$14,991,243, up from \$14,413,638 on June 30, 2022. A total of \$169,510 is in non-income-producing real estate, down from \$483,965 last year due to the sale of the Harrisonburg presbytery office property during the fiscal year. For this fiscal year, interest and dividend income on investments before expenses totaled \$336.890 (2.42% of investments in marketable securities at the beginning of the fiscal year) compared to \$265.075 (1.60%) in the previous fiscal year. Net realized and unrealized gain on marketable securities totaled \$1.406,247 compared to a \$2,031,307 loss in the previous fiscal year. Investment expenses were \$77,540 compared to \$80,325 last year. The overall investment portfolio (including cash and marketable securities) experienced a net investment income of \$1,665,597 or 12% of the beginning invested assets.

Investments held by the Corporation for this fiscal year ending June 30, 2023 comply with the Corporation's Investment Policy, which is stated as follows: Shenandoah Presbytery directs the Corporation to hold investments that satisfy the divestment criteria prescribed by Mission Responsibility Through Investment ("MRTI"), created and maintained by the Presbyterian Church (U.S.A.).

The Corporation supports and follows this policy based on these operational guidelines: The Corporation shall not hold stock directly in debt or equity securities of any MRTI listed entity; The Corporation may hold shares of mutual funds or exchange traded funds which invest in MRTI listed securities subject to the following limitations: The size of the Corporation's indirect listed holdings shall be so small as to be clearly immaterial and without economic influence when considered in relation to the Corporation's investment securities portfolio. This shall be determined by the following de minimis rule: The total value of indirect listed investments shall be immaterial so long as it is less than 2% of the total value of the Corporation's mutual fund portfolio.

It is spiritually fulfilling to be a part of the leadership team during the times of pastoral and church size transition for the last few years at SPC.

Wesley Theological Seminary in Washington D.C. is where I am attaining my seminary education, enrolled part-time in an online program. I am in my second year of education and receive a partial scholarship toward tuition. I enjoy the classes and experiences and am building community with my classmates who offer a diversity of backgrounds and denominations. It is a challenging and rewarding time for me in my sense of call.

I serve as the clergy representative and a chairperson on the Coordinating Committee of the WV Poor People's Campaign. #### REV. MICHAEL HAFELE BIOGRAPHICAL SKETCH

My faith journey began with my grandmother as my mother had me when she was 15 years old in Buffalo, NY and had the responsibilities of completing school and working to make ends meet. So, it was my devout Roman Catholic grandmother who dragged me to every conceivable Roman Catholic function that she could. My journey was one that started with a significant amount of whining and complaining. Nevertheless, my resolute grandmother was undeterred and expected me to abide by her desire to "make me a good young man." Over the next 9 years, I came to appreciate and value those outings with my grandmother. She later succumbed to breast cancer when I was 9 and I began to go to Mass as a memorial to her. My mother, during that period, had married, divorced, and remarried: the latter to a man Tom. Their marriage was rocky at first but as I reached 17 they began to attend a Presbyterian Church. As a Roman Catholic who both still wanted to honor my grandmother and appreciating the girls in the neighborhood who also went to Mass, I found that I was better off staying in the Roman Catholic Church rather than go to the Church where the name sounded funny. What served as the turn was that my parents' relationship began to improve dramatically. I was interested in what place provided such peace for the household, so my curiosity took over. In short, I probably heard the Gospel many times, but it was at the Presbyterian Church where it seemed so clear and moving for me. I began to volunteer with the youth and later the Pastor and the Session members welcomed me to consider full time ministry. My education landed me in South Central Virginia at Hampden-Sydney College and Princeton Theological seminary to follow. For the last 20 years, I cannot tell you all the absolute blunders I have made in ministry because they are too many to count but I have appreciated the grace offered to me by congregations and colleagues alike. I have been blessed to serve small, medium, and large congregations (mainly up and down the Eastern seaboard) which has welcomed me to see much of the similarities in Churches while also appreciating their nuanced distinctions. I believe that it is this breadth of experience that welcomes me to explore the need for and importance of adaptive leadership capacity in our contemporary setting, particularly within the context of a near post-pandemic world. My desire to continue my education found me at Fuller Seminary and Tod Bolsinger, known for his book, "Canoeing the Mountains," where opportunities to explore adaptive leadership in concert with transitional ministry has me approaching the Interim/Transitional ministry calling. It is my hope that the skills gleaned from the DMin program would be of service to small and midsized churches in the PCUSA where their budgets are constrained from bring in consultants to work with them in the area of adaptive leadership and who also may misinterpret the concepts. I am uncertain as to how that would be manifest but the desire and passion for supporting 85% of the churches in the denomination continues to move me forward.

All of this could not be done without the prayers and help of so many at every step of the way. The Lord has continued to encourage, press, push, hold, admonish, and love me through the highest of mountaintops and deepest valleys. My wife of 23 years, Claudia, has and continues to be the person I admire the most. She is wise beyond years, she challenges me, when necessary, her love is without parallel, she knows the human condition and counsels me on matters I am too blind to see. Our two "kids" are in their senior year in high school and both welcome me to see a world through the lens of teens. I admit, I am old.

I look forward to sharing ministry with First Pres in Winchester and to journey in faith and exploration as the Lord reveals their new Pastor to them and they to their new Pastor.

# REV. MICHAEL HAFELE STATEMENT OF FAITH EXPANDED

I affirm that I belong in mind, body, and spirit, not merely to myself but to my faithful Savior Jesus Christ.

I believe that there is only one God who is one in substance and yet distinct in three persons: the Father, the Son, and the Holy Spirit. I believe that the Triune God desires communion and intimacy with God's creation, particularly in the relationship with humanity. Humanity broke the relationship with God in wanton disobedience. In the midst of the brokenness of sin, God shows grace, mercy, and love as God covenants with humanity to bring forth deliverance, reconciliation, and ushers in the kingdom of God to all.

I believe in Jesus Christ, the second person of the Trinity, the one Living Word of God who was born, lived, died, resurrected from the dead, and now sits in glory. Christ is fully human and fully divine without confusion of the two natures. I believe that Christ proclaims the Kingdom of God through the ministry witnessed in the Gospel accounts thereby fulfilling the promises and prophecies proclaimed within the Hebrew Scriptures. It is in Christ that humanity is judged, and it is in Christ's voluntary act of love upon the cross and in the power of His resurrection that the chains of sin and death are broken and humanity is reconciled to God. Raised bodily from the dead at the resurrection as witnessed in Acts 1 at the ascension, Christ claims victory over sin and death and ushers in the Kingdom of God for a new humanity where communion with God is witnessed and proclaimed.

I believe in the Holy Spirit, the third person of the Trinity, who awakens and renews humanity, enabling and drawing humanity into repentance of sin, who guides the Church to answer the call of Christ, and inspire to embrace God's mercy that all might thus experience justification through Christ. The Holy Spirit initiates new life in Christ and, through the Holy Spirit, equips the Church with gifts for ministry, enabling to respond in joyful service, as the Counselor and Comforter empowers the Church to love God and others, and who seals the Church in Christ until the day of redemption. I believe that the Scriptures affirm two Sacraments: Baptism and the Lord's Supper which are signs and seals of incorporation into Christ and eating and drinking in communion with the crucified and risen Lord and the witness that within the fragility and weakness of humanity, God claims, calls, and seals God's own covenant people.

I believe that the Scriptures, in the Hebrew Testament and New Testament, are the unique and authoritative witness and account to Christ's life and ministry in bearing witness to God's unleashing and ushering in of the kingdom of God through witnessing to the Good News of the Gospel. The Scriptures are not a witness among many but a witness without parallel. The Scriptures, through the ministry of the Holy Spirit, are the Word of God written giving witness to the Living Word Jesus Christ. They are useful for teaching, for reproof, for correction, for training in righteousness, that the person of God may be complete and equipped for every good work.

I believe that the Church is the covenant and missional community of Jesus Christ gathered, equipped, preserved, and sent by God to serve as witness proclaiming Jesus Christ to all people in both word and work through the ministry of the Holy Spirit. There is one universal church of which Jesus Christ is the Head which consists of believers from all places and all times. As the chief end of humanity is to worship and enjoy the Lord forever, it is in worship, both personal and corporate, the community of faith is empowered to humbly yet dynamically glorify God. It is in service to all humanity and in the name of Jesus Christ that the Church exemplifies the Kingdom of God in a weary world. In the fulness of time, the Lord will return, as He ascended, to redeem all the created order in felicity and full communion with God where there will no longer be pain, suffering, and tears but joy and peace eternally.

# REV. RACHEL WATSON BIOGRAPHICAL SKETCH

I was born on December 21, 1978 and spent my early years in Greensburg, a small town in Indiana. My mother was a piano teacher and a church musician, so the house where I grew up was always filled with music. Consequentially, I have a deep love of classical, classic rock, and sacred music that is paired with a musical ability that does not do it justice. My father was a nurse. My grandfather was the pastor at the Presbyterian church in the town and we lived just a few blocks from my grandparents. Every Sunday morning, you could find me tagging along beside my grandmother, a child of the church. When I was six, my mother and I moved to Houston, Texas, where she had taken a job as a music teacher in the public schools there. She was still working as a church musician and, as an only child of a now single mom, if something was happening at the church, I was probably there. When I was eight, my mom took a new job at Saint Stephen Presbyterian Church, a small church in Houston. This was the church that raised me, saw me through so many milestones of life, and cared for me while I began my seminary journey.

I grew up in the church, learning theology at choir rehearsals and liturgy as it was brought into familiar newness at worship committee meetings as I sat on the floor coloring beside my mom. I attended Sunday School and VBS and youth group. With family, discussion of the church's faithful response in the world was a necessary pairing with lively political banter around the dinner table and I was encouraged to participate. At church and at home, I was surrounded by examples of faith. I was encouraged to ask questions and explore my faith. I was given the opportunity to see faith in action. It would take pages to tell about all the people that influenced me. But the one that truly taught me to be a disciple was my grandmother. She led by example, not by force. She had a knack for sensing someone's gifts and lifting them up. While her demeanor was gentle, she was a force to be reckoned with if something was not just. She worked tirelessly to make the world a better, more peaceful place. I was formed in her love and taught by her example.

I knew I wanted to be a pastor when I was six years old. I remember asking my grandfather for a copy of the Book of Common Worship when I was ten because I loved the words and I loved planning worship services for my family on Sunday afternoons. He eventually obliged, giving me my own little blue pastoral edition, reminding me that ministry was much more than just reciting those words. My grandfather always encouraged my journey of faith, not by telling me what to believe, but by teaching me to ask questions and make it my own. As I finished my degree in psychology at the University of Houston, I explored the possibility of seminary, talking to my grandfather about McCormick, where he had studied, and visiting with our DCE, who told me about the dual degrees in Christian Education and Divinity at Union.

But ultimately, I became an elementary school teacher. I loved teaching and working with children and for seventeen years, I built communities and nurtured young minds within the walls of my classroom. I was active in my congregation, serving on the session, as a liturgist, and as a Sunday school teacher. When I felt a tug toward the ministry, I reminded myself that I was doing God's work in my life as a teacher.

Then a young minister, straight out of seminary, was called to our church and he invited my husband and me to lunch to get to know us, a part of his new congregation. He asked me what I did, and I launched into a justification for why I was not a minister even though I thought about it a lot and how being a teacher was still doing God's work. When I was finally finished, he and my husband stared at me. It was a complicated answer to a simple question. To be honest, it surprised me too. I realized that I still had some deep discernment to do that had been eating away at me for a long time.

Over the next few years, opportunities were presented that illuminated a gift I had found hard to acknowledge, comments were made that watered the seed that was trying to bloom, and excuses were batted down one by one. I was encouraged to lift my preaching voice by that young pastor. My former Sunday school teachers asked me to lead them in their studies. I was given opportunities to lead the church in new discernment. Their words silenced the doubt so I could hear God's call. God is persistent and patient. Thanks be to God.

So in 2018, with three kids and a husband, I moved to Austin and began my studies at Austin Presbyterian Theological Seminary. During my time at the seminary, I was a research assistant, an instructional aide, and a chapel beadle. I was hungry to learn all of it, diving into theology of liturgy, the multiple lenses that deepen the way we understand scripture, and the ways to care for and tend to the people of God in community, in both academics and in practice.

In the Spring of 2020, I began my internship. Then, six weeks later, the pandemic shut the city down. I got a front seat to learn how to be a pastor in a pandemic and how do church in a completely new way. I got to wrestle with the theological questions of online church and find the intersections with the pastoral care of a congregation under stress. While I longed for the connected church to return to the building, I loved the process of thinking about how to do the central things of worship, education, and fellowship when our patterns had changed and how it had forever changed the church.

Graduating from seminary in May of 2022, I agreed to remain at the church where I had served as an intern. I'd started there as a facilitator for Christian formation and remained there as a seminary fellow when they lost two associate pastors in the pandemic. Then, as a stated supply associate pastor, I cared for the congregation, participated in worship leadership, navigated hybrid church, and brought the Christian formation program back in person as we returned to the building. We stretched and grew in faith together.

And now I am stepping into a second call as an associate pastor at Covenant in Staunton, where I have the honor of being able to help people of all ages find their place in the story of the people of God and to care for the family of God in the church as the Church journeys into new ways of being in a changing world. I'm excited to see what God has in store for us as we walk this journey of faith together.

# REV. RACHEL WATSON STATEMENT OF FAITH

I believe in God who creates and sustains all that is.

God, the all-powerful creator, fashioned humankind and the world in which God set them so that all could grow and thrive in beloved community.

Created in God's image, humankind is endowed with creativity and the capacity to love. God rejoices as this creativity is used to question, make sense of, and care for God's earth, God's animals, God's plants, and God's people in constructive, loving ways. Breathing upon us a spirit of mercy in our darkest moments, God is here. Breathing upon us a spirit of love when we fail to serve our siblings in Christ, God is here. Breathing upon us a spirit of grace when others need to see God's love through us, God is here. Again and again, we are re-formed by the Spirit to try once again to walk in the footsteps of the one through whom we have been saved, Jesus Christ, until we join the community of saints in the kin-dom of Heaven.

#### I believe that God is Love.

By God's love, we are created. By God's grace, we are saved. By God's mercy, we are reformed. Creator, Redeemer, Reformer. Love, Grace, Mercy. Parent, Child, Spirit. #### Presbytery Meeting Ad Hoc Task Force

Thanks to all who took time to participate in the survey about Presbytery meetings! We had 154 responses from across the Presbytery, 110 from Ruling Elders and church members, and 44 from Teaching Elders.

Based on the feedback and conversation within the CPC, the following meeting dates and formats have been set for 2024:

- Tuesday, February 27th, 9:30am on Zoom
- Tuesday, May 14, 9:30am in person (location TBD)
- Saturday, September \_\_\_\_\_, in conjunction with the Big Event at Massanetta Springs (date TBD)
- Tuesday, November 12, 9:30am on Zoom

#### Here is some of what we heard:

- A clear preference for weekday mornings:
- whether in person or online, weekday mornings were listed as top choice, for both Ruling Elders and Teaching Elders, above all other options.
- whether in person or online, weekday mornings had the lowest number of respondents (both REs and TEs) for whom that time wouldn't work.
- Weekday evenings and Sunday afternoons were the least workable meeting options for all participants.
- Nearly half of all Ruling Elders also stated that Saturday meetings do not work for them, whether in person or online.
- More than half of all participants preferred a continued combination of Zoom and in person meetings
- Multiple suggestions for adding more opportunities for learning and fellowship together when we gather in person
- Multiple requests for Zoom to be an option for all meetings, even when meeting in person
- Many positive comments about the increased accessibility of Zoom, including travel considerations for distance, time, weather conditions, health issues, etc
- Requests for agendas and meeting materials to be distributed earlier

After much discussion, the CPC approved the meeting schedule for 2024, with the understanding that CPC will evaluate and assess these changes before making recommendations for 2025.

Though we heard the requests for hybrid meeting options for in person meetings, there were prevailing concerns about our capacity to commit to that at this time, in terms of bandwidth and internet capabilities in our churches, concerns about adequate resources (technical and volunteer), and questions about equity in participation and voting. While we cannot commit to offering that in 2024, CPC will keep that in mind as we plan future meetings.

We recognize that there isn't a magic meeting time, day, or format for everyone within the Presbytery. Our hope is to reinvigorate the collegial and relational aspects of Presbytery meetings, while also increasing accessibility for all members. Thank you for your engagement and feedback. As we proceed through the year ahead, please continue to share your feedback with the CPC.

Purpose: To provide processes and support for congregations that have an identified need, willingness, and ability to engage in spiritual and/or programmatic growth which can lead to deeper commitment both within and beyond current membership.

#### Committee on Educational Resources (CER)

Purpose: To provide education and resources in the areas of stewardship, children's ministry, youth and young adult ministry, evangelism, social justice issues, and other areas related to congregational ministry through the use of specialized teams and regional and presbytery-wide training events.

# Committee on Mission and Outreach (CMO)

Purpose: Coordinate and oversee local, national, and international mission work through congregations and mission communities. CMO will provide information, resources, encouragement and support.

# Committee on New Congregational Development (CNCD)

Purpose: To formulate and implement a comprehensive plan for location, funding, and development of new congregations and new worshipping communities within the bounds of the presbytery.

#### Committee on Nominations (CN)

Purpose: To nominate to Presbytery individuals to serve on presbytery committees, adhering to established norms of committee membership and representation including vacancies, chairs and vice-chairs; and to nominate persons to serve on presbytery's PJC and as commissioners to Synod and General Assembly meetings.

## Committee on Pastoral Transition (CPT)

Purpose: To fulfill all Book of Order and Presbytery Manual responsibilities related to oversight of and guidance to churches and pastors in the process of moving from one pastor/congregation relationship to another. These responsibilities include work related to dissolving pastoral relationships, working with churches in all processes leading to the next pastor call, and examining teaching elders for readiness and suitability to receive calls.

#### Committee on Preparation for Ministry (CPM)

Purpose: To oversee the care and examination of inquirers and candidates for ministry, inform sessions of the process for inquiry and candidacy, and conduct examinations of candidates seeking calls within the bounds of this presbytery.

# Committee on Presbytery Administration (CPA)

Purpose: To oversee the management of presbytery funds, property, and staff.

#### Committee on Relational Ministry (CRM)

Purpose: To fulfill all Book of Order and Presbytery Manual responsibilities related to oversight of and assistance to churches and teaching elders in their ministry. These responsibilities include all matters related to matriculation of new pastors, periodic visits with sessions and pastors, support for clergy wellness and continuing education.

# Committee on Representation (COR)

Purpose: To advise the Presbytery with respect to membership of its committees and to the employment of its personnel per Book of Order G-3.0103.
