
The 200th Stated Meeting of Shenandoah Presbytery will be held on Tuesday, February 27, 2024, at 9:30 am via Zoom.



John 3: 16-17

"For God so loved the world that he gave his only Son, so that everyone who believes in him may not perish, but may have eternal life. Indeed, God did not send the Son into the world to condemn the world, but in order that the world might be saved through him."

This year, Ash Wednesday falls on Valentines Day.

A real mis-match, you might think. When contemplating the 40 days leading to the cross, cards and hearts and chocolates (something we might give up for Lent) seem garish and wrong.

But if we focus on love, the amazing love of God, the abundant, astounding love shown in Christ, the uniting, unifying love we experience in the Holy Spirit, it seems appropriate.

One of my favorite hymns is "What Wondrous Love." (#215 in the Glory to God hymnal). Coming out of the Southern Harmony song book, there is no author or composer known to us. But this song lifts up the amazing love of God. Its last stanza, in out hymnbooks, says "and when from death I'm free, I'll sing on..."

Which leads me to another favorite hymn, "How can I keep from singing?" Also known as "My Life Flows On," (#821) and is attributed to "Pauline T.," but our hymnal gives credit to Robert Lowry for both text and music.

This song also speaks to that wondrous love, that above all strife and turmoil, the Easter promise still continues: that Christ has conquered death and sin, and is Lord of heaven and earth, and Lord of all our lives.

That, friends, is reason for singing about the wondrous love given to us.

May you have a blessed Lent, and through these 40 days, may you sing God's goodness.



Thomas Rhyne, Former Front Royal Church Pastor, Publishes Book

Dr. C. Thomas Rhyne, Hon. Ret., of Strasburg, Virginia has recently published a history of two colonial families in the Lower Shenandoah Valley.

Titled The Poor Jamaica Man's Plague: Mary Butler and John Tipton, Colonials in Transition, 1747-1783, the book chronicles the major social, economic, and political events that touched the lives of the Butler and Tipton families from the French and Indian War through the Revolutionary War and beyond when the Butler family moved to the Ohio Country and the Tipton family moved to western North Carolina. The experiences of the Butlers and Tiptons mirror those of many a colonial during this time of great upheaval and change.

IRS Mileage Rates

IRS issues standard mileage rates for 2024; mileage rate increases to 67 cents a mile, up 1.5 cents from 2023

WASHINGTON — The Internal Revenue Service today issued the 2024 optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes.

Beginning on Jan. 1, 2024, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) will be:

- 67 cents per mile driven for business use, up 1.5 cents from 2023.
- 21 cents per mile driven for medical or moving purposes for qualified active-duty members of the Armed Forces, a decrease of 1 cent from 2023.
- 14 cents per mile driven in service of charitable organizations; the rate is set by statute and remains unchanged from 2023.

These rates apply to electric and hybrid-electric automobiles as well as gasoline and diesel-powered vehicles.

The standard mileage rate for business use is based on an annual study of the fixed and variable costs of operating an automobile. The rate for medical and moving purposes is based on the variable costs.
